Defined Benefit Plan

On July 11, 2008, the Fund held its regular Investment Committee meeting. In attendance were Trustee Gerard Cruz and I. Other Attendees were Paula Blas and Diana Bernardo.

Informational Items:

1. Contracts

The Committee discussed the status of the contracts for the following:

- a. Custodial Bank Services
- b. Real Estate Investment Trusts (REITs)
- c. U.S. Domestic Small Cap Core Equity
- d. U.S. Domestic Core Fixed Income
- e. U.S. Domestic Large Cap Growth Equity

2. Asset Allocation

The Committee reviewed the asset allocation as of July 9, 2008 noting the following:

- a. For **Domestic Large Cap Equity** the 30% Policy Allocation will be allocated equally amongst each of the managers.
- b. For **Non US Equity Developed Markets** the 12% Policy Allocation will be allocated as follows:
 - 1. 10% to Fisher International, and
 - 2. 2% to AXA International
- c. For Non US Equity Small Cap the 5% Policy Allocation will be allocated as follows.
 - 1. 0.5% to AXA International, and
 - 2. 4.5% to Dimensional Fund Advisers
- d. For **Fixed Income** the 30% Policy Allocation will be allocated equally amongst each of the managers.
