#### V. DIRECTOR'S REPORT - EXECUTIVE SUMMARY

- 1. Defined Benefit (DB)/Defined Contribution (DC) Plan Alternatives Director Paula Blas stated that a Public Hearing on Bill 266-33 is scheduled for Monday, February 29, 2016, at 3:00 p.m. Chairman San Agustin stated that Senator Michael San Nicolas' intention is Social Security for GovGuam employees.. Secretary Antolina Leon Guerrero stated that based on a meeting with Maggie Ralbovsky of Wilshire Associates, Vice Speaker B.J. Cruz is asking for the Retirement Fund to submit a technical commentary on the provisions of Bill 266-33. Trustee David O'Brien stated that the Retirement Fund is not taking a position. Ms. Ralbovsky stated that the testimony she wrote is neutral. Director Blas stated that the testimony is being prepared and should be submitted within ten (10) days.
- 2. Standard Insurance Director Blas stated that an updated summary report as of January 31, 2016 on the status of applications and individuals on Group Long Term Disability (LTD) is provided for the Board's information.

# Financial Report

- 1. Contributions Director Blas stated that as of February 23, 2016, all agencies are current with their Fiscal Year 2016 employee and employer contributions with the exception of the Guam Memorial Hospital Authority (GMHA).
- 2. Financial Statements Director Blas stated that the books for the month ended December 31, 2015 were closed on February 10, 2016 and the books for the month ended January 31, 2016 is scheduled to close by March 4, 2016.

## VI. THIRD PARTY ADMINISTRATOR'S REPORT

A. Contribution Report – January 2016

Director Blas stated that Alice Taijeron, Director, Client Relations & Plan Counseling, Empower Retirement provided the TPA Report for the month ending January 31, 2016 on the DC Retirement System 401(a) Plan and the 457 Deferred Compensation Plan. Ms. Taijeron stated that GMHA is up to date with 457 loan payments for their employees.

Ms. Taijeron stated that the 401(a) Plan had total assets of \$402,247,457.02. There was a decrease of \$14,685,117.91 or -3.52%. There was a market decrease of -0.04% from December 2015 to January 2016. There was a market decrease of -3.00% in the Fourth Quarter 2015. The 457 Deferred Compensation Plan had total assets of \$43,587,664.44. There was a decrease of \$1,395,547.64 or -3.10%. There was a market decrease of -0.05% from December 2015 to January 2016. There was a market decrease of -4.00% in the Fourth Quarter 2015.

Ms. Taijeron stated that the 401(a) Plan had total contributions of \$3,054,233.49. There was a decrease in contributions of \$29,465.63 or -0.96%. The 457 Deferred Compensation Plan had total contributions of \$701,232.11. There was an increase in contributions of \$228,269.50 or 48.26%. Ms. Taijeron stated that the 401(a) Plan had 149 employee distributions totaling \$1,632,218.87. The 457 Plan had 27 participant distributions totaling \$318,290.68.

Treasurer Gerard Cruz, seconded by Trustee David O'Brien, moved to accept the Third Party Administrator's Report. Without objection, the motion passed.

#### A. Investment Committee

Vice Chairman Wilfred Leon Guerrero reported that the Investment Committee Meeting was held on February 25, 2016. The Committee reviewed and approved the Investment Committee Meeting Minutes of December 11, 2015 and the October 29, 2015 Due Diligence Meeting Minutes for the Quarter Ended September 30, 2015.

Next Quarterly Performance Meeting – Vice Chairman Leon Guerrero informed the Board that the next Quarterly Performance Meeting is scheduled for April 28, 2016.

Treasurer Gerard Cruz, seconded by Trustee David O'Brien, moved to accept the Investment Committee Report. Without objection, the motion passed.
