1. Termination of Eaton Vance

Maggie Ralbovsky of Wilshire Associates stated that Wilshire's recommendation is to terminate Eaton Vance due to several turnovers of their management team over the past years, or to keep them on Watch until October 2017 as approved by the Investment Committee at their May 26, 2016 meeting. Vice Chairman Gerard Cruz suggested to transfer Eaton Vance's assets to Numeric Investors. Ms. Ralbovsky stated that Northern Trust could conduct the transition, if necessary.

Committee Vice Chairman Gerard Cruz, seconded by Committee Member Albert Santos, moved to accept Wilshire's recommendation to terminate Eaton Vance and to transfer their assets to Numeric Investors. Without objection, the motion passed.

2. Keep Capital International on Watch

Ms. Ralbovsky stated that Wilshire's recommendation is to keep Capital International on Watch.

Committee Vice Chairman Gerard Cruz, seconded by Committee Member Albert Santos, moved to accept Wilshire's recommendation to keep Capital International on Watch. Without objection, the motion passed.

3. Place Earnest Partners on Watch

Ms. Ralbovsky stated that Wilshire's recommendation is to place Earnest Partners on Watch.

Committee Vice Chairman Gerard Cruz, seconded by Committee Member Albert Santos, moved to accept Wilshire's recommendation to place Earnest Partners on Watch. Without objection, the motion passed.
