IV. NEW BUSINESS

1. Active Manager Searches for Passive Index Funds

Maggie Ralbovsky of Wilshire Associates stated that a restructuring of the equity investments will benefit the portfolio and therefore Wilshire's recommendation is to conduct a search for three (3) new managers for the Passive Index Funds.

Committee Member Albert Santos, seconded by Committee Chairman Wilfred Leon Guerrero, moved to accept Wilshire's recommendation to conduct a search for Three (3) New Passive Index Fund Managers. Without objection, the motion passed.

2. Place Numeric Investors on Watch

Ms. Ralbovsky stated that Numeric Investors underperformed significantly since inception, but still above the benchmark. Numeric has offered the Retirement Fund a 25 basis points fee reduction from the current 75 basis points per year. Ms. Ralbovsky stated that Wilshire's recommendation is to place Numeric on Watch for the next 24 months and to accept Numeric's fee amendment from 75 basis points per year to 50 basis points per year.

Committee Member Albert Santos, seconded by Committee Chairman Wilfred Leon Guerrero, moved to accept Wilshire's recommendation to place Numeric Investors on Watch for 24 Months and to accept Numeric Investors' Fee Amendment from 75 Basis Points Per Year to 50 Basis Points Per Year. Without objection, the motion passed.
