Committee Chairman Gerard Cruz, seconded by Committee Member Thomas San Agustin, moved to maintain Fisher Investments as a Manager and to Defund Fisher Investments' International Equity Investments into BlackRock EAFE Index Fund. Without objection, the motion passed.
