I. CALL TO ORDER

The Retirement Fund Investment Committee Meeting for the Defined Benefit Plan was called to order at 11:39 a.m. Thursday, August 27, 2020, in the Retirement Fund Conference Room. Investment Committee Chairman Artemio Hernandez officiated.

II. ACTION ITEMS

1. July 30, 2020 Regular Investment Committee Meeting Minutes

Maggie Ralbovsky of Wilshire Associates mentioned that there are some open items: the two searches that were placed on hold and there is one search that was not initiated yet, which is the Global Listed Infrastructure Securities. The two searches placed on hold were the International Developed Non-US Equity and the U.S. Domestic Small Cap Equity Managers. Controller Diana Bernardo indicated that she will add the open items to the agenda.

1. DB Plan Quarterly Performance

Committee Chairman Hernandez stated that during the Due Diligence meetings, Ms. Ralbovsky provided an overview of the Global Economic Outlook and the Investment Performance for the quarter ended June 30, 2020. She noted that the Retirement Fund's portfolio outperformed it's benchmark index, ranking at the 37th percentile of Wilshire's peer group universe for the quarter. The Retirement Fund Return for the quarter was 12.64% and the Benchmark Return was 12.43%.
