# V. REVIEW AND FINDINGS (Correspondences)

1. **COR 04-11** RE: Marc A. Gagarin, Department of Public Works

REQUEST: To pay outstanding balances for redeposit of service credit,

identified in Promissory Note #2226 dated July 22, 1993.

DISCUSSION: Mr. Gagarin executed promissory note #2226 for redeposit

of service credit on July 22, 1993. The commencement date for payroll deduction was to begin PPE August 07,

1993 and terminate on PPE July 19, 1997.

FINDINGS: Evidence suggests that there was a disconnect between Mr.

Gagarin and his payroll office. However, by not issuing notification of non-compliance, we (the Fund) also are remiss in not allowing for due process. Therefore, we recommend **CONDITIONAL APPROVAL** subject to repayment of the balance within thirty (30) days of notice.
