Mrs. Rosario A. Untalan is applying for Disabled Adult survivor benefits on behalf of Joseph JI Untalan and Gil AI Untalan. Mrs. Untalan is the legal guardian of the disabled adults. The disabled adults are the biological children of deceased retiree Gil H. Untalan who passed away on January 20, 2004.

In support of her application, Mrs. Untalan has provided the birth certificates of the disabled adults, two (2) Report of Medical Examination of Minor child disability forms for each disabled adult, the Order Appointing herself and Mr. Gil H. Untalan as the legal guardians of the two disabled adults. She has also provided the death certificate of Mr. Untalan.

Case summary- additional information: This summary, in addition to previously submitted documents, is being presented to the current committee at its February 15, 2012 for review and re-approval of a previously approved Adult Disabled Survivor Stipend application

Upon the death of Mr. Gil H. Untalan, Mrs. Rosario A. Untalan was processed as a surviving spouse annuitant. Upon completion of her processing for survivor benefits, Mrs. Untalan was advised on the stipends available, upon approval by the Board of Trustees for disabled adult survivors.

Mrs. Untalan subsequently submitted documents for disabled adult survivor stipends on behalf of her two step-sons, Joseph JI Untalan and Gil H. Untalan on January 23, 2004. The documents were compiled and prepared for presentation to the Members' and Benefits Committee at their February 24, 2004 regular meeting.

The presentation was accepted and the application was moved by the committee to the Board of Trustees for their review and disposition at their April 28, 2004 regular meeting. The board of Trustees approved this application as presented on this date.

Upon being approved by the Board, the process continues with the applicant being notified of the approval and is advised to return to the Fund to continue the process which includes the signing of documents as well as submission of additional documents which may be required. The preparation of an annuity worksheet is then completed and submitted to payroll for benefit payments. However, Mrs. Untalan did not return to the Fund to complete this process, nor did the Fund follow-up with the application.

On Monday, December 19th, 2011, the Fund was advised of Mr. Joseph JI Untalan's death. Mrs. Untalan's survivor pension file was retrieved for review. Upon review of the file, it was noted that the application for the disabled adult stipends were not completed and therefore the payments were not effectuated. This payment should have been made retroactive to the date of Mr. Gil H. Untalan's death.

Mrs. Rosario Untalan was contacted and advised to meet with a benefit specialist to complete the processing forms for submission and routing to the payroll section for immediate payment of stipend benefits due to deceased adult disabled survivor Joseph JI Untalan and Mr. Gil AI Untalan. The documents were completed and processed on December 22, 2011.
