A review of deceased Retiree Julia D. L. Tydingco's file has determined that upon her death on September 19,1999, her daughter, Judith A. Tydingco met the criteria to apply for the Adult Disabled Survivor Benefit Stipend pursuant to PL 24-189 and \S (c) 4 G.C.A.

Judith A. Tydingco was the adult disabled survivor of Julia D.L. Tydingco and has since expired on November 05, 2005.

Gordon W. Tydingco, the Court Appointed Guardian of Judith A. Tydingco is applying for adult disabled benefits on her behalf. The duly processed benefits would have been paid to her court appointed guardian identified in Special Proceedings Case No. SP 055-98 filed with the Fund on November 8, 1999. A retroactive payment of the adult disabled stipend is due to Gordon W. Tydingco from the date of death of the retiree which was September 19, 1999 to the date of death of the disabled adult survivor on November 5, 2005.

In support of his application, Mr. Tydingco has provided a copy of the Court Ordered Guardianship, a copy of Ms. Judith Tydingco's birth certificate, two (2)

Report of Medical Examination of Minor Child disability forms, a copy of Ms. Tydingco's death certificate as well as a copy of the death certificate of their deceased mother.
