#### II. REVIEW AND APPROVAL OF BOARD MINUTES

A. April 21, 2006 Regular Meeting

#### III. DIRECTOR'S REPORT - EXECUTIVE SUMMARY

- 1. Defined Contribution Statutory Amendments Acting Director Paula Blas stated that Bill 293 was signed by the Governor on July 18, 2006. Acting Director Blas stated that the document is ready for signature.
- 2. Request for Proposal (RFP): Defined Contribution Investment Consultant Services Acting Director Blas stated that there are four qualified offerors for this RFP. Acting Director Blas stated that Secretary James Taylor will chair the Evaluation Committee along with two Retirement Fund staff.
- 3. Request for Proposal (RFP): Third Party Administrator Acting Director Blas stated that the RFP for Third Party Administrator has been reviewed by the Investment Committee with changes. Acting Director Blas stated that the RFP is ready for issuance. Acting Director Blas stated that changes were incorporated in the RFP. A summary sheet which indicates the changes was provided to the Board. Chairman San Agustin stated that the third party arrangement is separate from the Defined Benefits Plan. Chairman San Agustin asked about the welfare benefit. Acting Director Blas stated that it is the administration portion. Treasurer Gerard Cruz mentioned the annual review with Great West Retirement Services' performance. Acting Director Blas stated that it was outsourced to Standard Insurance. Chairman San Agustin stated that the Fund does not need to outsource. Chairman San Agustin stated that the Fund is responsible. Chairman San Agustin asked that the Board review the Plan Document.

Secretary Taylor asked what action needs to be taken. Acting Director Blas replied, "to approve the RFP." Secretary Taylor requested to add the Morning Star report as item i on Section 143 on Page 21. Chairman San Agustin recommended having Secretary Taylor review the Plan Document. Secretary Taylor stated that he is concerned with the rebates. Acting Director Blas stated that it is under Section 104 on Page 19.
