Controller Bernardo indicated that in the draft, Mercer is recommending a discussion with the Committee on the 3 firms named. Dr. Leon Guerrero stated that the Committee had already decided on Galliard as the replacement for INVESCO and wanted it stated for the record that the Committee was considering companies named on the list provided by GreatWest, which were a list of options different from what was recommended by Mercer. Director Blas stated that Mercer can add on to their list but it is up to the Board to make a decision to accept what they offer. The Committee members agreed to stay with the recommendation of Galliard.
