I. CALL TO ORDER

IV. Watch List Policy

Acting Director Blas stated that the Watch List Policy is still in draft form. Included were samples, as requested by the committee, from other states and organizations. Committee Chairman Leon Guerrero recommended submitting it to the Board for review.

V. OPEN ITEMS

As reported by Acting Director Paula Blas:

1. Legal Services - Transaction Monitoring Services

The panel met with the top three (3) firms yesterday and will report to the Board in the next meeting for recommendation and approval.

2. DC Investment Consultant

The panel is ready to evaluate and have received four (4) offers. The panel is suppose to be headed by Committee Member James Taylor with two (2) staff members, but will be held off until his return on August 13, 2006. Committee Chairman Leon Guerrero asked that Controller Diana Bernardo work with Committee Member Taylor on this item.

3. Global Custody Search

This item had been brought forward to the Board, however, as per his request, Committee Member Taylor had reviewed and suggested changes, which Acting Director Blas had made and given back to him for his review. Due to his absence, Acting Director Blas will provide to Committee Chairman Leon Guerrero, a copy of what she had given to Committee Member Taylor to review.

VI. INFORMATIONAL ITEMS

1. Funding of Managers - Fisher, DFA, AXA, and Capital

Controller Bernardo gave an update from the last Investment Committee Meeting reporting that Fisher and DFA have been funded, and a letter is expected to be sent to First Hawaiian Bank for funding of Capital. She also noted that Appendix A of the AXA Contract has been revised and AXA has requested that the performance benchmark be changed from MSCI EAFE Small Capitalization Equity Index to the S&P Citigroup World ex US EMI Index. She indicated that based on discussions with Mercer the change can be made. Committee Member Gerard Cruz suggested that Controller Bernardo obtain more information from Mercer as to how the index is chosen, which would be a more accurate index to use and the

difference between the two. He also suggested that she review the historical index on a 10, 5, 3 and 1 year basis to determine which one was higher before she contacts Mercer.

2. Transition Manager

Committee Chairman Leon Guerrero inquired as to whether the Fund can issue an RFP to have a transition manager on board. Committee Member Cruz inquired as to whether the Fund can use an existing manager. Acting Director Blas stated that she will confirm with Legal Counsel.

3. Forum for Investment Advisors - Sept. 13 and 14, 2006
