## NOTICE OF ELECTION

Pursuant to 4 GCA § 8138.1 (2) & 2 GAR § 3407 the Government of Guam Retirement Fund announces that the Guam Election Commission will conduct an

The purpose of the election is to elect Active and Retiree members to serve on the Board of Trustees of the Government of Guam Retirement Fund.

The term of office of a Trustee is **five (5) years** from the date the Trustee first takes the oath of office following the Trustee's election.

### **For Potential Candidates**

Upon Notice of an Election, a prospective Candidate seeking election shall submit a Candidate Statement and Nominating Petitions in the form provided by the Board. Nominating Petitions shall be signed by no less than one hundred fifty (150) persons who are eligible to vote as members or retirees of the Fund or Retirement System. A prospective Candidate shall indicate on the Candidate Statement whether he/she seeks Office as an Active Member or a Retiree. If the prospective Candidate seeks nomination as a Retiree, the prospective Candidate shall certify that he/she is domiciled in Guam. **Deadline to submit applications for candidacy is 5:00 p.m., Friday, February 21, 2024, at the Guam Election Commission.**

### **Early Voting**

Early voting will take place **from Monday, April 29, 2024 to Thursday, May 2, 2024, 8:00 am to 5:00 pm** at the office of the Guam Election Commission, 241 Farenholt Ave., Oka Building, Tamuning, Guam.

### **Absentee Ballot Application**

The Guam Election Commission will begin accepting Absentee Ballot Applications from eligible voters who are home bound, or will be off-island on the day of the election. Deadline to submit absentee applications for individuals who will be off-island on election day is **Wednesday, May 1, 2024 5:00 p.m.**
